

Cookie statement Meditation Moments

We are Meditation Moments B.V. (hereinafter: "we", "us" or "Mediation Moments") we have our registered office and place of business in (3828 PK) Hoogland, the Netherlands, at the Slaagseweg 10.

In this cookie statement we explain how and why we may process the information as described in this cookie policy when you use our application ("App") and/or website, www.meditationmoments.com ("Website").

What are Cookies?

Cookies are small data files that are placed on your computer, tablet, mobile phone or other device to ensure that a system can collect and send information. When visiting our Website or App, we (and third parties we work with) may use cookies and similar technologies - like web beacons, pixels and SDK's, no matter whether these technologies install code or data on your device or not - (together "Cookies") to, for example, recognize you, improve the user-friendliness of our Website and App and measure the effectiveness of our Website, App and promotions.

What Cookies do we use?

The Cookies we may use have different functions and fall into the following categories:

1. **Functional Cookies:** Cookies that are necessary for the functioning of our Website and App and increase the usability thereof. For example: they allow you access to our Website and App, identify irregular functioning of our Website and App, help to prevent fraudulent activity, improve security, or allow you to use the functions of our Website and App such as creating an account, saving login information and making a payment. According to current legislation we do not need your permission to use these Cookies.
2. **Analytical Cookies:** Cookies that for example help us to assess the performance and effectiveness of our Website and App, and understand how our visitors use our Website and App and help us to improve our Website and App. We only use these Cookies with your consent. Third-party Cookies may be used as well. We refer you to the relevant third party's privacy policy as set out below in our Cookie overview.
3. **Marketing Cookies:** Cookies that allow us and third parties to show you relevant advertisements. For example Cookies that track whether you have accessed our Website or App through an advertisement on a third party's website and Cookies that allow us to measure, optimize and build audiences for our promotion campaigns. We only use these Cookies with your consent. Third-party Cookies may be used as well. We refer you to the relevant third party's privacy policy as set out below in our Cookie overview.

The specific Cookies we use may change from time to time. You can find more information about the specific Cookies we use below. We will update the overview regularly.

Disable/decline Cookies

Certain aspects and features of our Website and App are only available through the use of Cookies. When you disable or decline certain Cookies, your use of our Website or App may be limited or not possible.
